### **COLLEGE HOUSE SECURITY**

*Bowdoin Student Government, convened in General Assembly*

**WHEREAS**, there have been concerns from students about their safety moving around campus at night;

**WHEREAS**, there have been concerns from students about their safety moving through the town of Brunswick at night;

**WHEREAS**, there have been concerns about the safety of students off campus;

**WHEREAS**, the Bowdoin Student Government has observed complaints from Brunswick community members about the behavior of Bowdoin students living off campus

**WHEREAS**, the Bowdoin Student Government convened in general assembly noted the specific goals:

To create an estimate of the cost of installing overhead lighting on the path from Edwards to Brunswick Apartments.

To create an estimate of the cost of installing overhead lighting around the perimeter of the Main Quad.

To keep the lights on the exterior Hubbard Hall, Visual Arts Center, and Searles Hall on until 5 am.

To create an estimate of the cost of installing motion activated lighting on the exterior Hubbard Hall, Visual Arts Center, Searles Hall, Hyde Hall, Appleton Hall, Maine Hall, and Winthrop Hall.

To reach out to town officials about the possibility of creating more lighting on Federal Street.

To reach out to the Brunswick Police Department about the ways in which BSG can work with the BDP to keep student's safe.

**NOW, THEREFORE, BE IT**

**R**ESOLVED, That the members of Bowdoin Student Government, convened in

General Assembly—

1. That the Bowdoin Student Government will create an Ad Hoc Committee For Lighting and Campus Safety.
